

Lease Statistics (FY2023)

[Key Points]

- Total lease transaction volume: 4,629.9 billion yen, increased by 7.4% compared with the volume in FY2022.
- Leasing capital investment: 4,324.3 billion yen, increased by 7.2% compared with the volume in FY2022.
- Leasing percentage: 4.30%
- Components of total lease transaction volume: "All Equipment" increased. "Large Companies" and "Small and Medium Sized Companies" and "Public sector and Others" all increased.
- Leasing capital investment (Consolidated basis): 9,204.8 billion yen, increased by 10.2% compared with FY2022 (Increased by 8.7% for domestic, Increased by 13.4% for overseas).

◆ Total Lease Transaction Volume and Leasing Capital Investment

Total lease transaction volume for FY2023 was 4,629.9 billion yen, a increase of 7.4% compared with FY2022; and leasing capital investment was 4,324.3 billion yen, a increase of 7.2% compared with FY2022, total lease transaction volume and leasing capital investment showed increase in a row of 2 years.

◆ Leasing percentage

Leasing percentage (ratio of leasing capital investment to the total private capital investment) in FY2023 was 4.30%; i.e. approximately 4% of private capital investments were made through leasing.

◆ Lease Transaction Volume by Type of Equipment

Transport Equipment (17.8% up) had showed double-digit increase. Information and Communication Equipment (6.5% up), Office Equipment (4.6% up), Industrial Equipment (2.0% up), Factory Equipment (7.5% up), Construction Equipment (7.1% up), Medical Equipment (7.2% up), and Commercial and Service Equipment (5.0% up) had also showed all types positive growth.

◆ Lease Transaction Volume by Size of Lessee and Lessee's Business Type

"Small and Medium Sized Companies" (companies with capital of 0.1 billion yen and less or solo proprietors) which accounted for approximately 50% of total lessees showed a rise (11.9% up) in a row of 2 years. "Large Companies" (companies with capital of over 0.1 billion yen) a rise (1.1% up) in a row of 2 years. "Public sector and Others" showed a rise (7.5% up) for the first time for the last 2 years.

"Manufacturing" (9.1% up) and "Non-Manufacturing" (8.4% up) had increased in a row of 2 years respectively.

◆ (Reference) Consolidated Lease Statistics (FY2023)

Leasing capital investment for FY2023 on a consolidated basis was 9,204.8 billion yen, an increase of 10.2% compared with FY2022. Components were 6,242.1 billion yen for domestic leasing (8.7% up) and 2,962.7 billion yen for overseas leasing (13.4% up).

Lease Statistics (April 2024)

The lease transaction volume in April 2024 is 436.7 billion yen, increased by 22.0%, compared with the same period of the last year. The lease transaction volume had showed increase in a row of 2 months. With regard to the type of equipment, Information and Communication Equipment (27.0% up), Office Equipment (13.7% up), Industrial Equipment (14.1% up), Construction Equipment (11.4% up), Transport Equipment (28.7% up), Medical Equipment (5.5% up), and Commercial and Service Equipment (0.6% up) had showed increased respectively. On the other hand, Factory Equipment (8.2% down) had showed decreased.

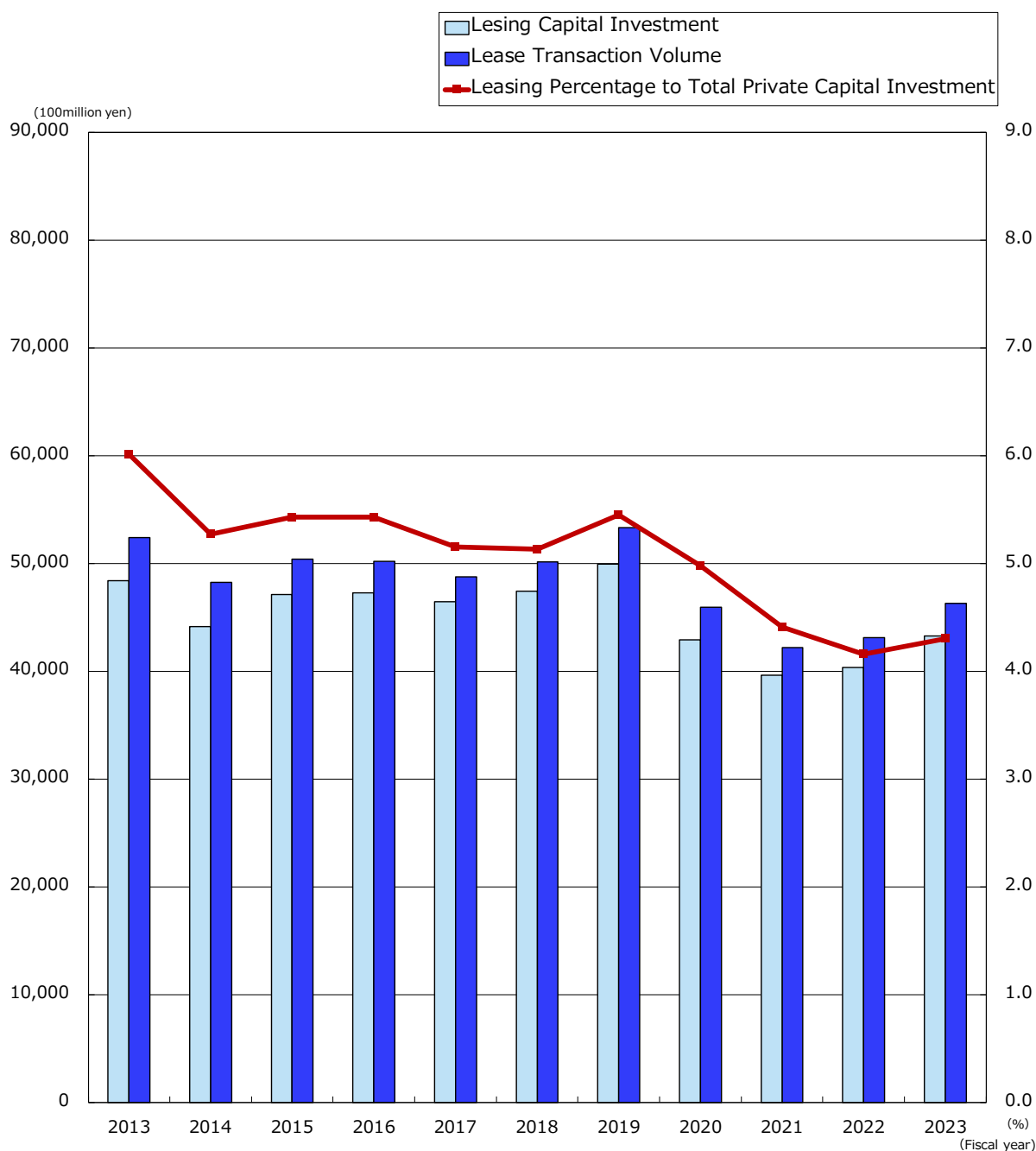

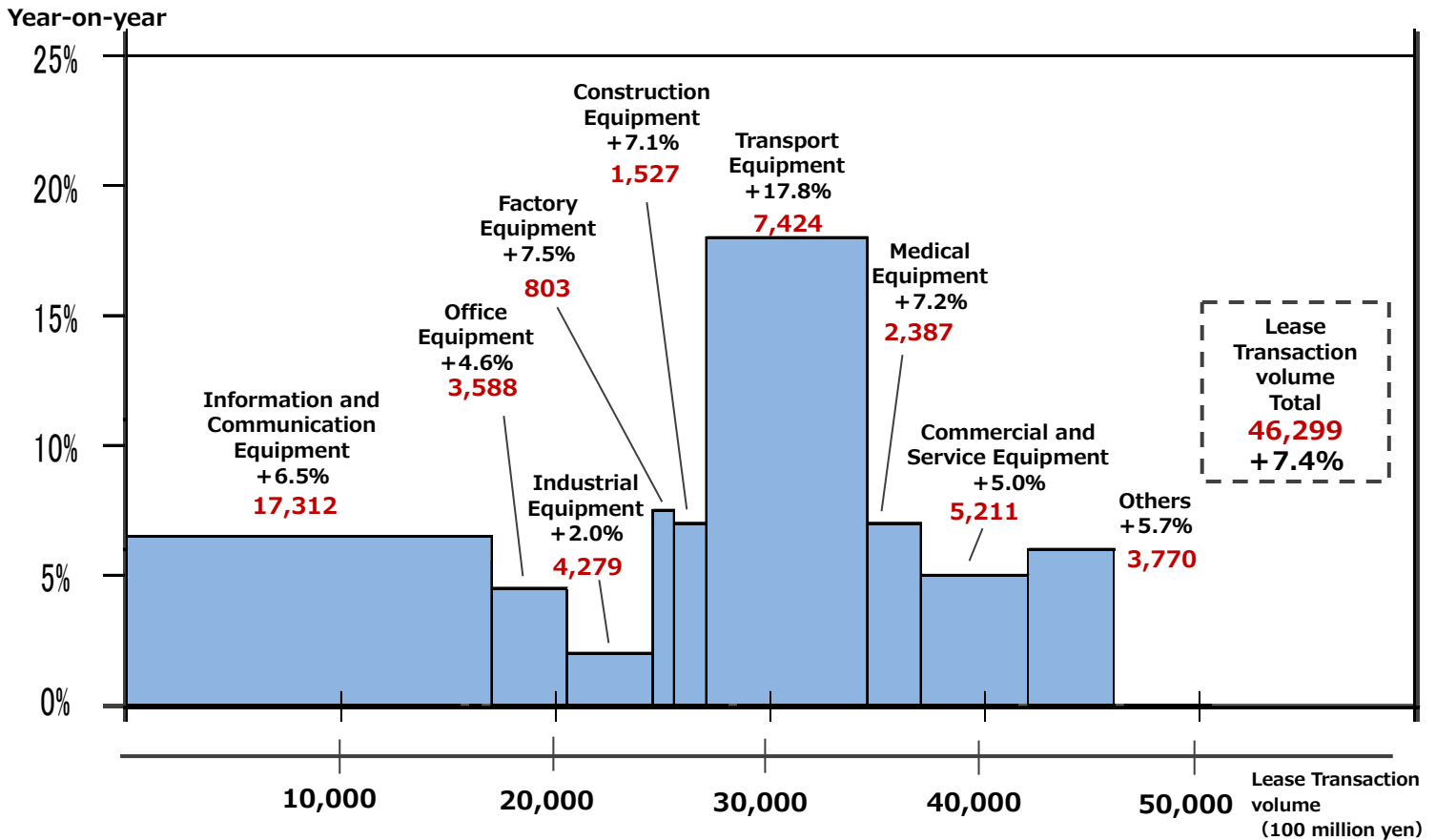

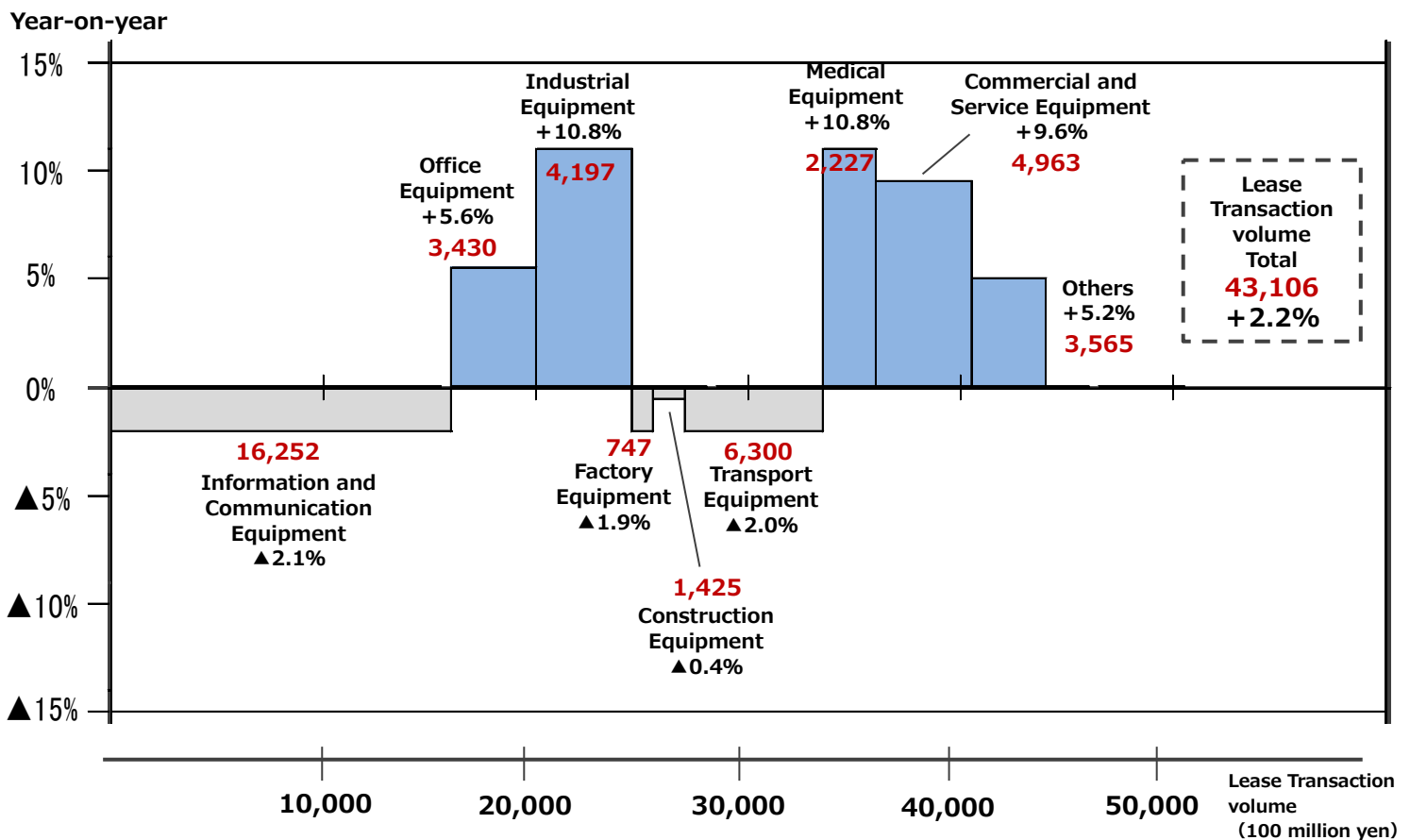

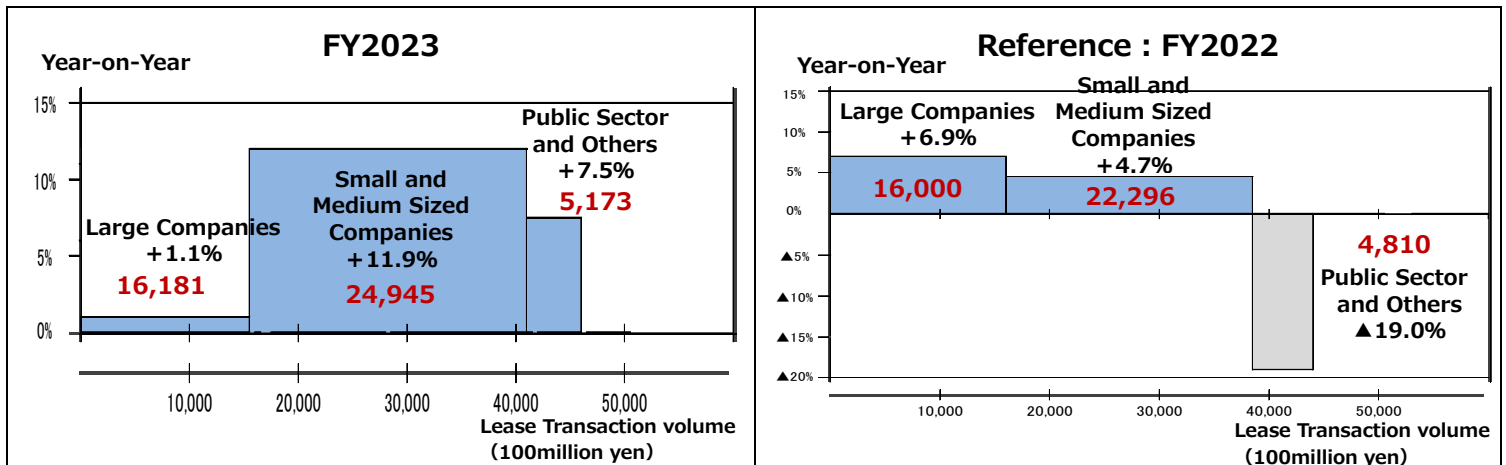

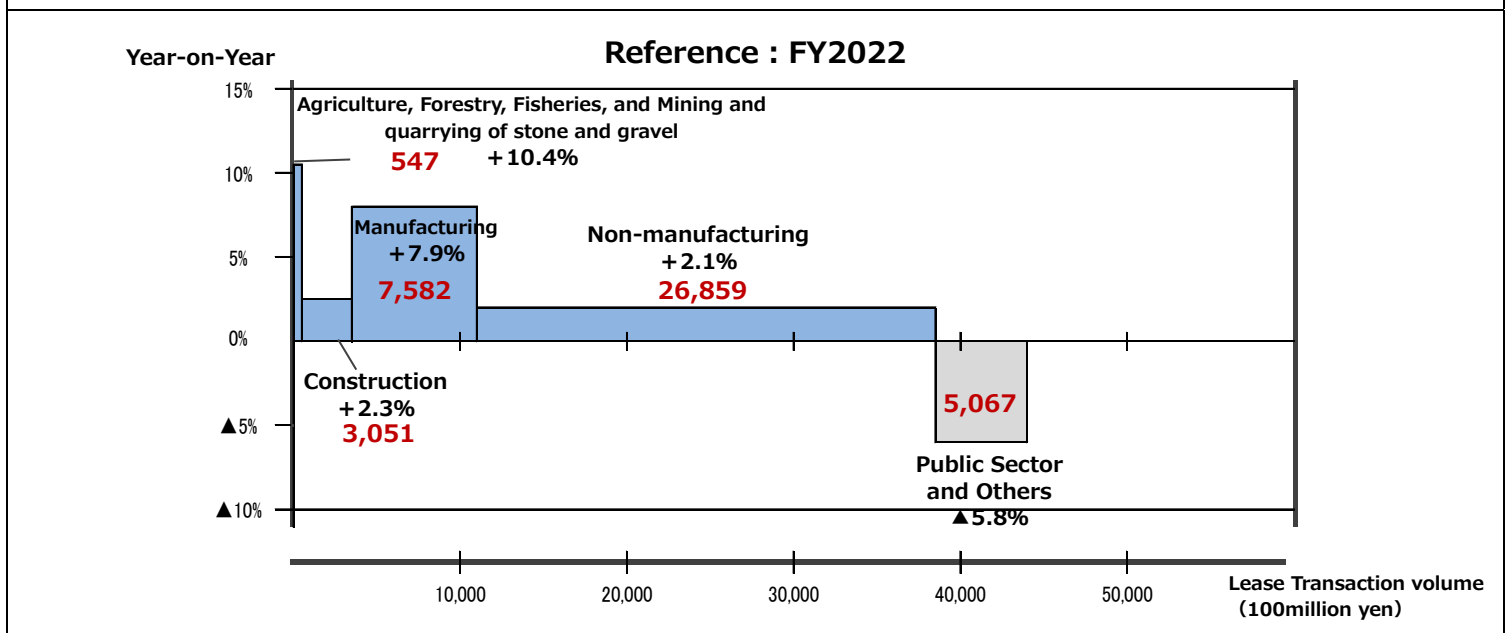
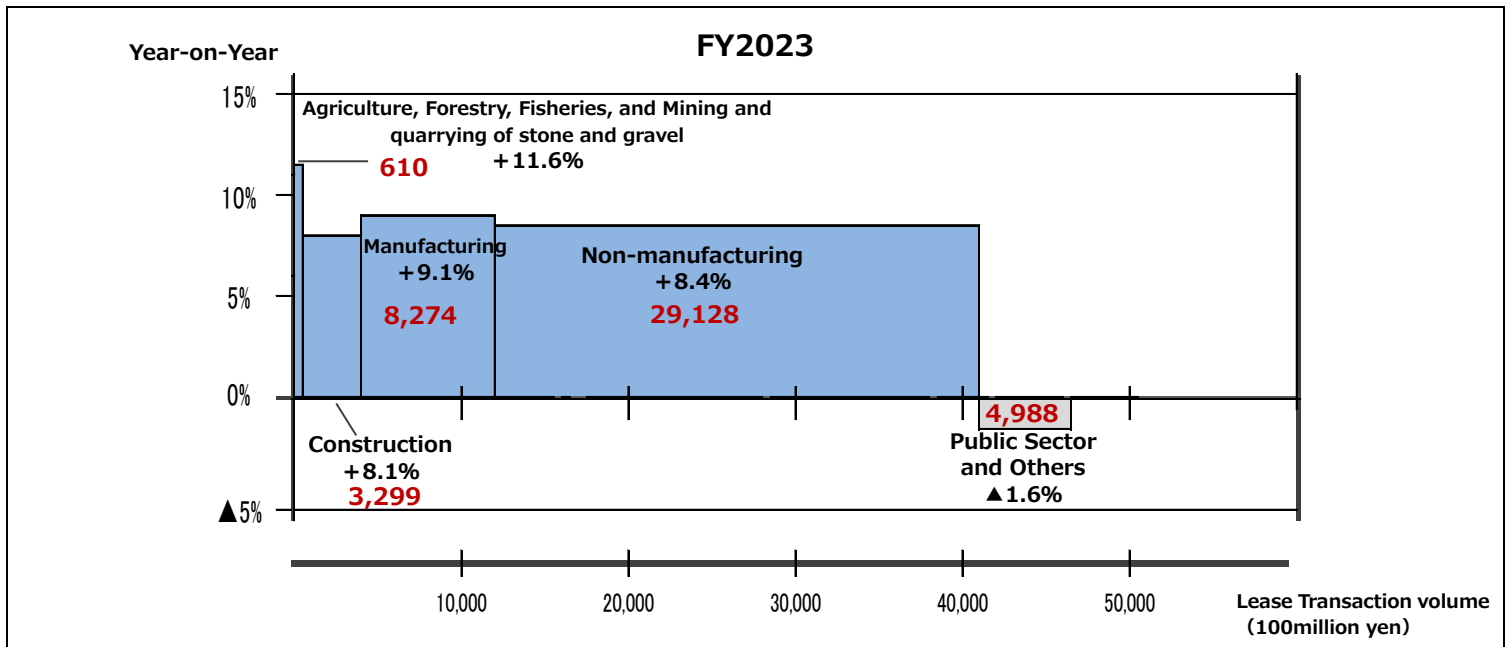
Trends in Lease Transaction Volume by Size of Lessee and Lessee's Business Type

<Trends in Lease Transaction Volume by Size of Lessee>

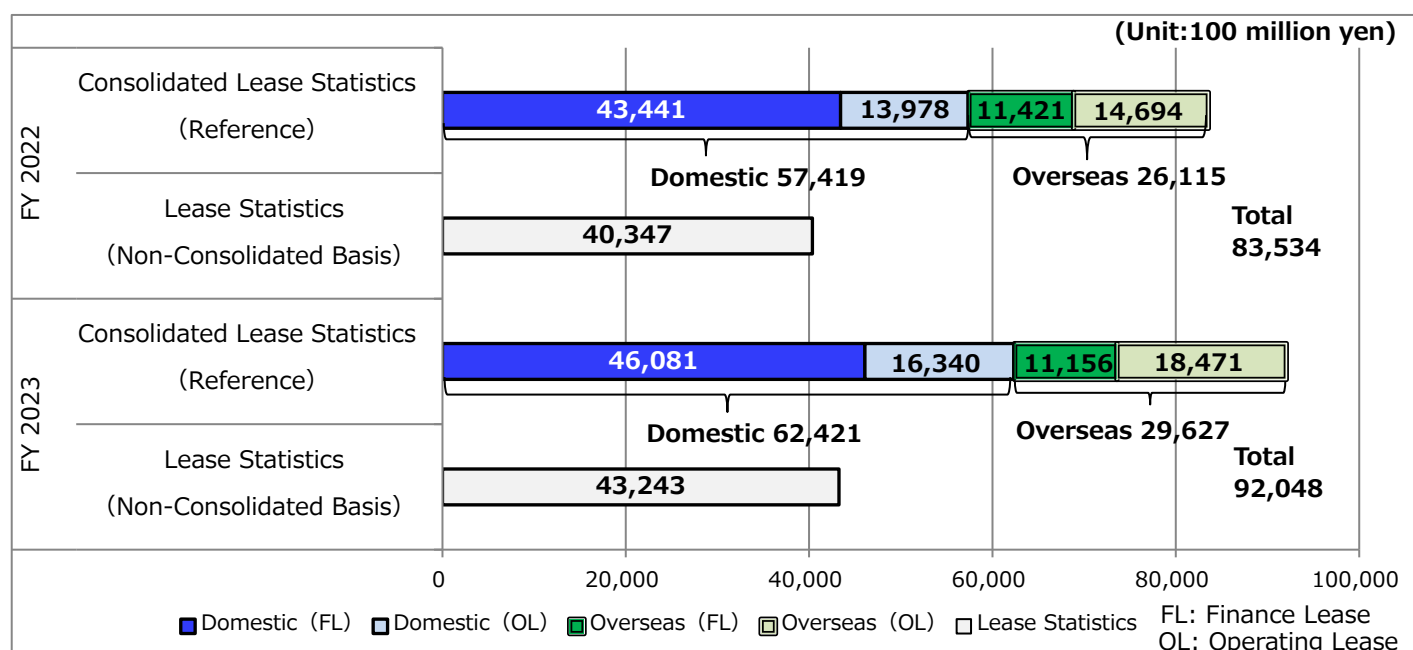


<Trends in Lease Transaction Volume by Lessee's Business Type>

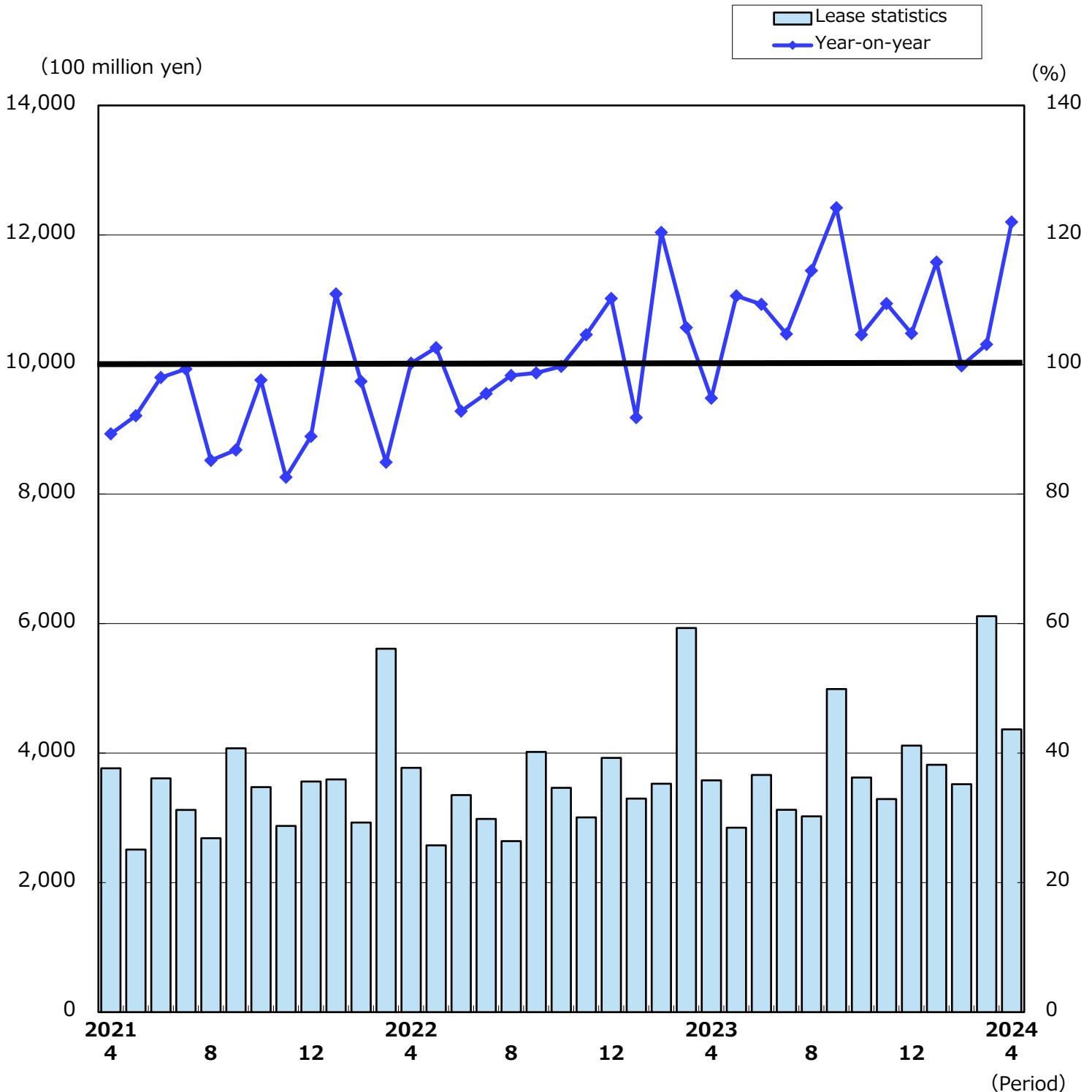

(Overview)

- The lease transaction volume in April 2024 is 436.7 billion yen, increased by 22.0%, and increased in a row of 2 months.
- Information and Communication Equipment (27.0% up), Office Equipment (13.7% up), Industrial Equipment (14.1% up), Construction Equipment (11.4% up), Transport Equipment (28.7% up), Medical Equipment (5.5% up), Commercial and Service Equipment (0.6% up) increased.
- Factory Equipment (8.2% down) decreased.
