

Lease Statistics (FY2024)

[Key Points]

- Total lease transaction volume: 5,084.7 billion yen, increased by 9.8% compared with the volume in FY2023.
- Leasing capital investment: 4,671.0 billion yen, increased by 8.0% compared with the volume in FY2023.
- Leasing percentage: 4.34%
- Components of total lease transaction volume: “Information and Communication Equipment”, and “Transport Equipment” and “Commercial and Service Equipment” double-digit increased. “Large Companies” and “Small and Medium Sized Companies” and “Public sector and Others” all increased.
- Leasing capital investment (Consolidated basis): 10,379.9 billion yen, increased by 12.8% compared with FY2023 (Increased by 7.5% for domestic, Increased by 23.9% for overseas).

◆ Total Lease Transaction Volume and Leasing Capital Investment

Total lease transaction volume for FY2024 was 5,084.7 billion yen, a increase of 9.8% compared with FY2023; and leasing capital investment was 4,671.0 billion yen, a increase of 8.0% compared with FY2023, total lease transaction volume and leasing capital investment showed increase in a row of 3 years.

◆ Leasing percentage

Leasing percentage (ratio of leasing capital investment to the total private capital investment) in FY2024 was 4.34%; i.e. approximately 4% of private capital investments were made through leasing.

◆ Lease Transaction Volume by Type of Equipment

Information and Communication Equipment (18.9% up), Transport Equipment (12.3% up), and Commercial and Service Equipment (13.6% up) had showed double-digit increase. In addition, Office Equipment (0.5% up), Factory Equipment (1.0% up) had been increased. On the other hand, Industrial Equipment (9.7% down), Construction Equipment (4.5% down), and Medical Equipment (0.3% down) had turned to negative growth.

◆ Lease Transaction Volume by Size of Lessee and Lessee's Business Type

“Small and Medium Sized Companies” (companies with capital of 0.1 billion yen and less or solo proprietors) which accounted for approximately 50% of total lessees showed a rise (9.0% up) in a row of 3 years. “Large Companies” (companies with capital of over 0.1 billion yen) a rise (3.9% up) in a row of 3 years. “Public sector and Others” showed a rise (32.3% up) in a row of last 2 years.

“Manufacturing” (2.8% down) had decreased for the first time for the 3 years.

“Non-Manufacturing” (9.8% up) had increased in a row of 3 years.

◆ (Reference) Consolidated Lease Statistics (FY2024)

Leasing capital investment for FY2024 on a consolidated basis was 10,379.9 billion yen, an increase of 12.8% compared with FY2023. Components were 6,708.8 billion yen for domestic leasing (7.5% up) and 3,671.1 billion yen for overseas leasing (23.9% up).

Lease Statistics (April 2025)

The lease transaction volume in April 2025 is 441.2 billion yen, increased by 1.0%, compared with the same period of the last year. The lease transaction volume had showed increase in a row of 7 months. With regard to the type of equipment, Information and Communication Equipment (3.5% up), Office Equipment (4.1% up), Factory Equipment (1.5% up), Medical Equipment (11.5% up), and Commercial and Service Equipment (3.0% up) had showed increased respectively. On the other hand, Industrial Equipment (3.6% down), Construction Equipment (13.9% down), Transport Equipment (1.7% down) had showed decreased respectively.

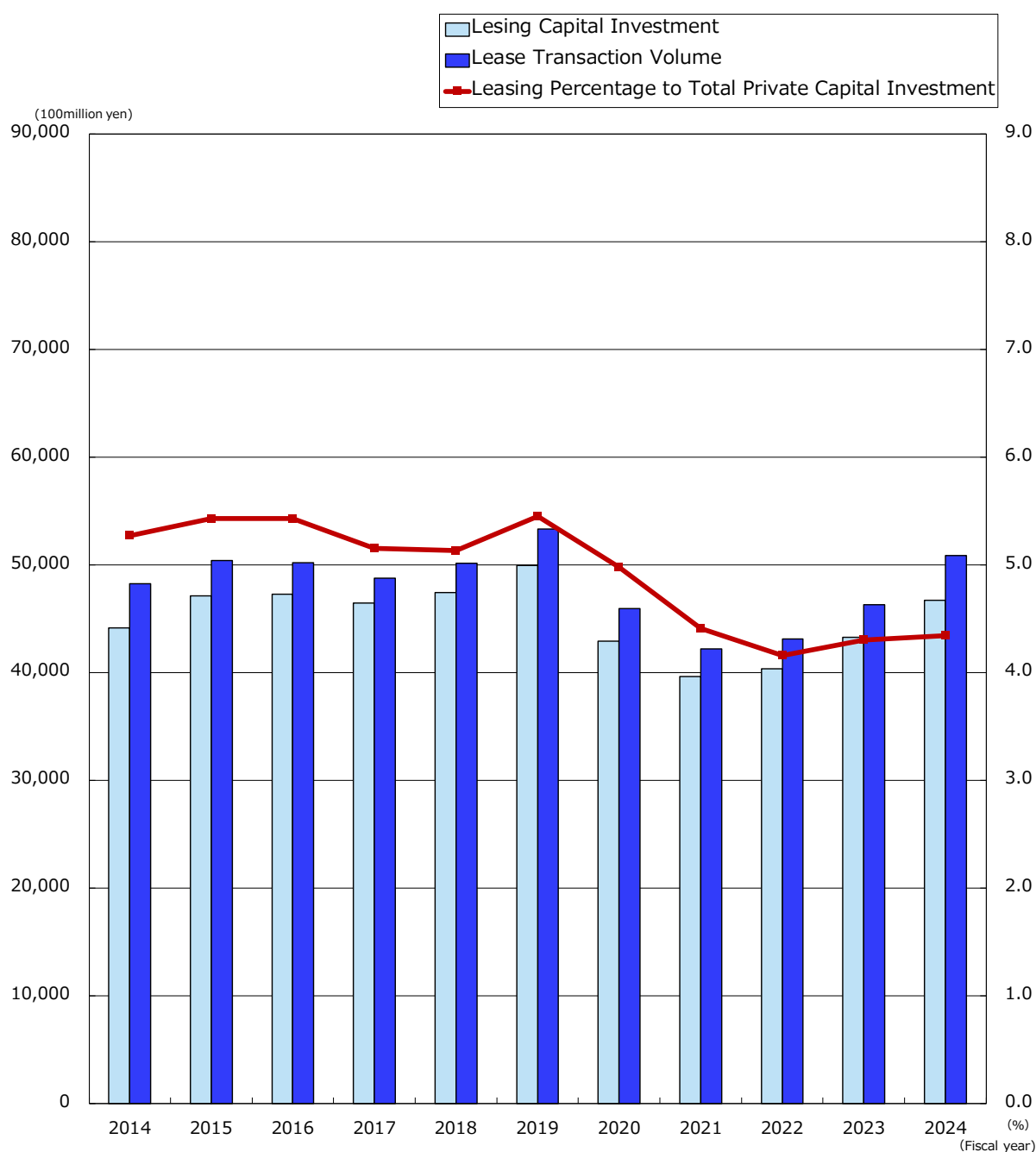

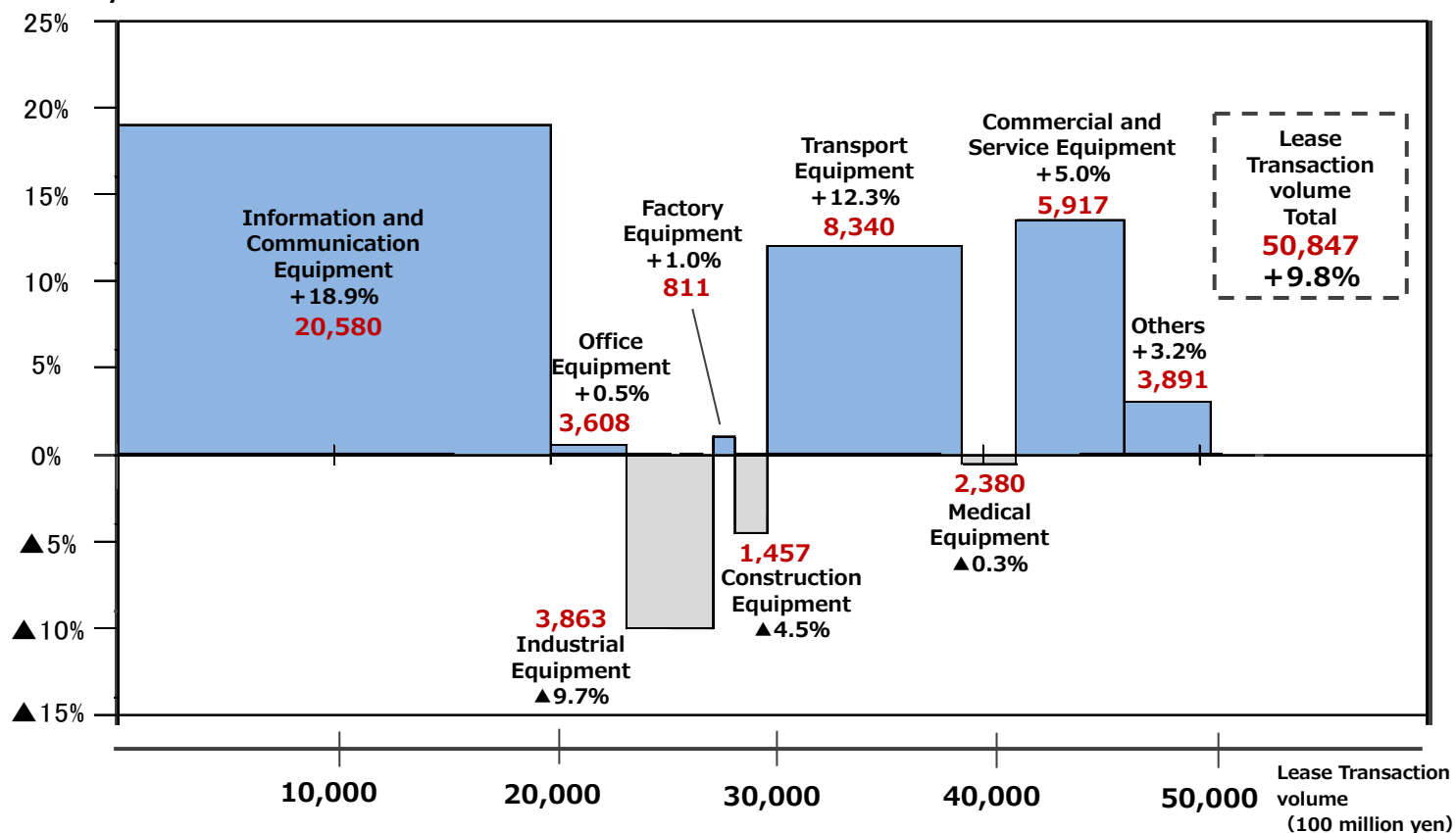

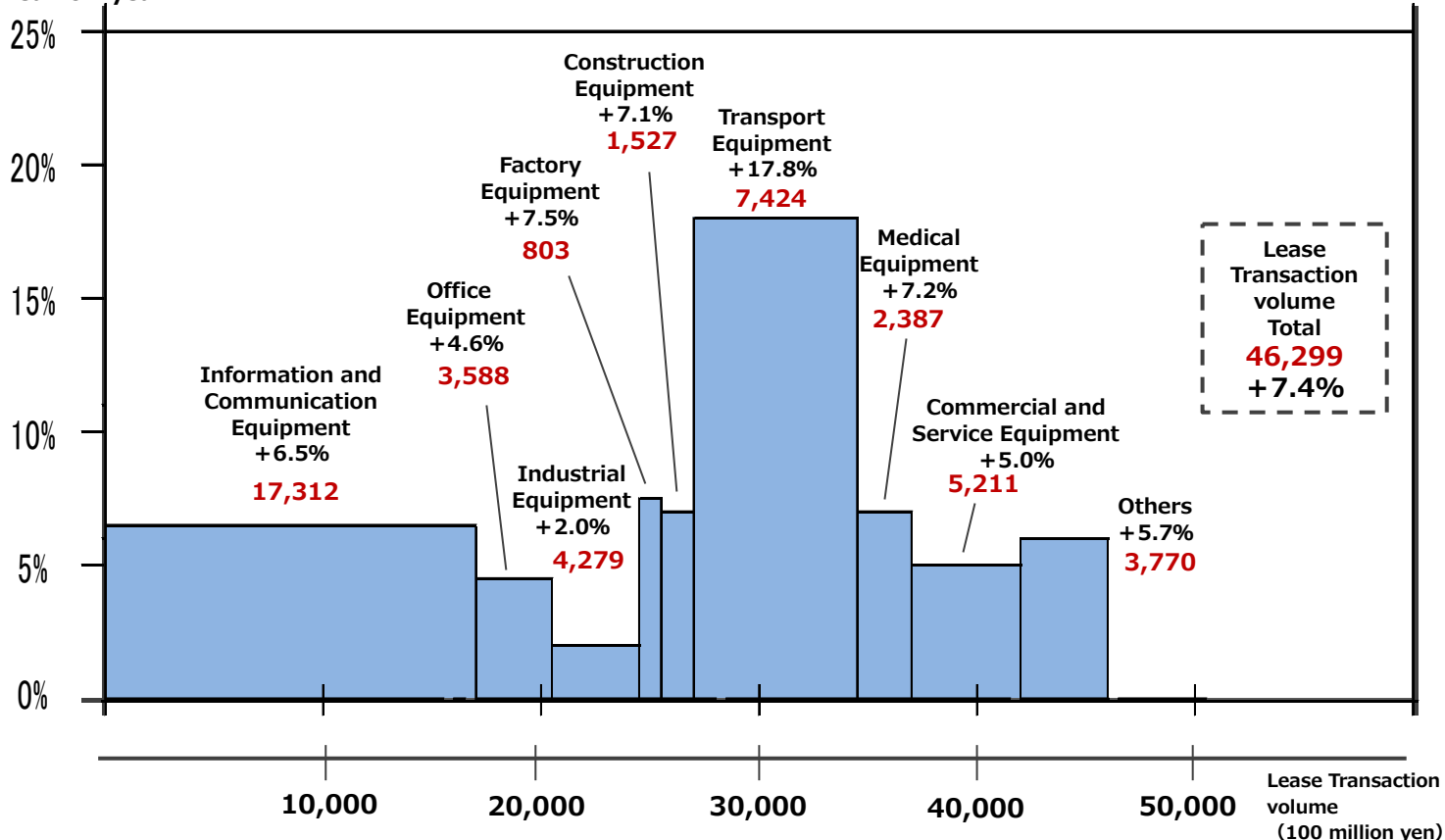

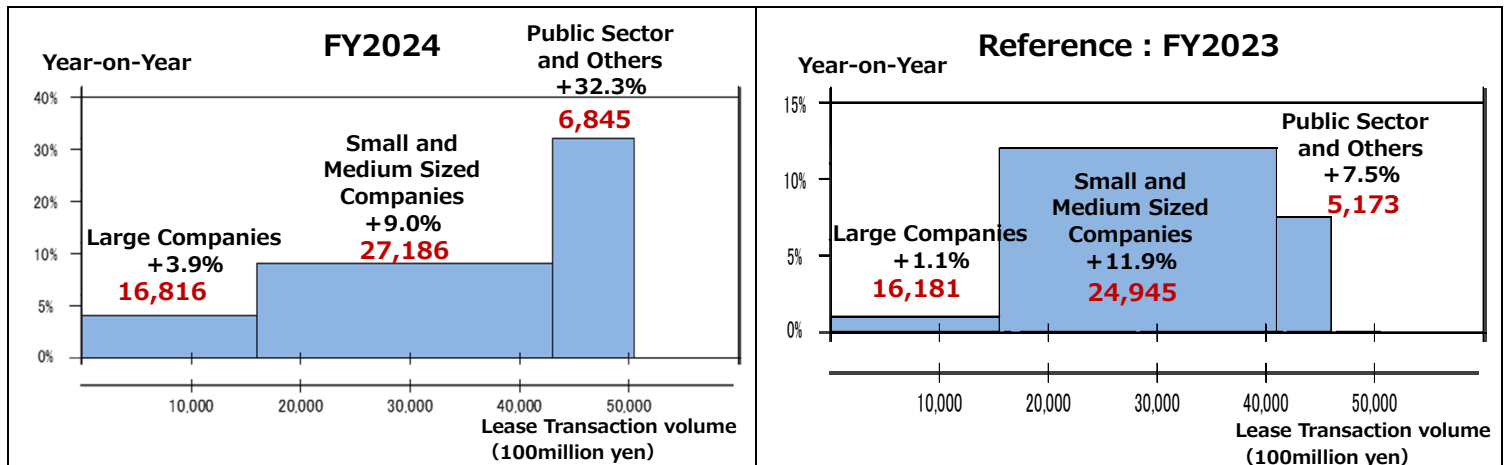

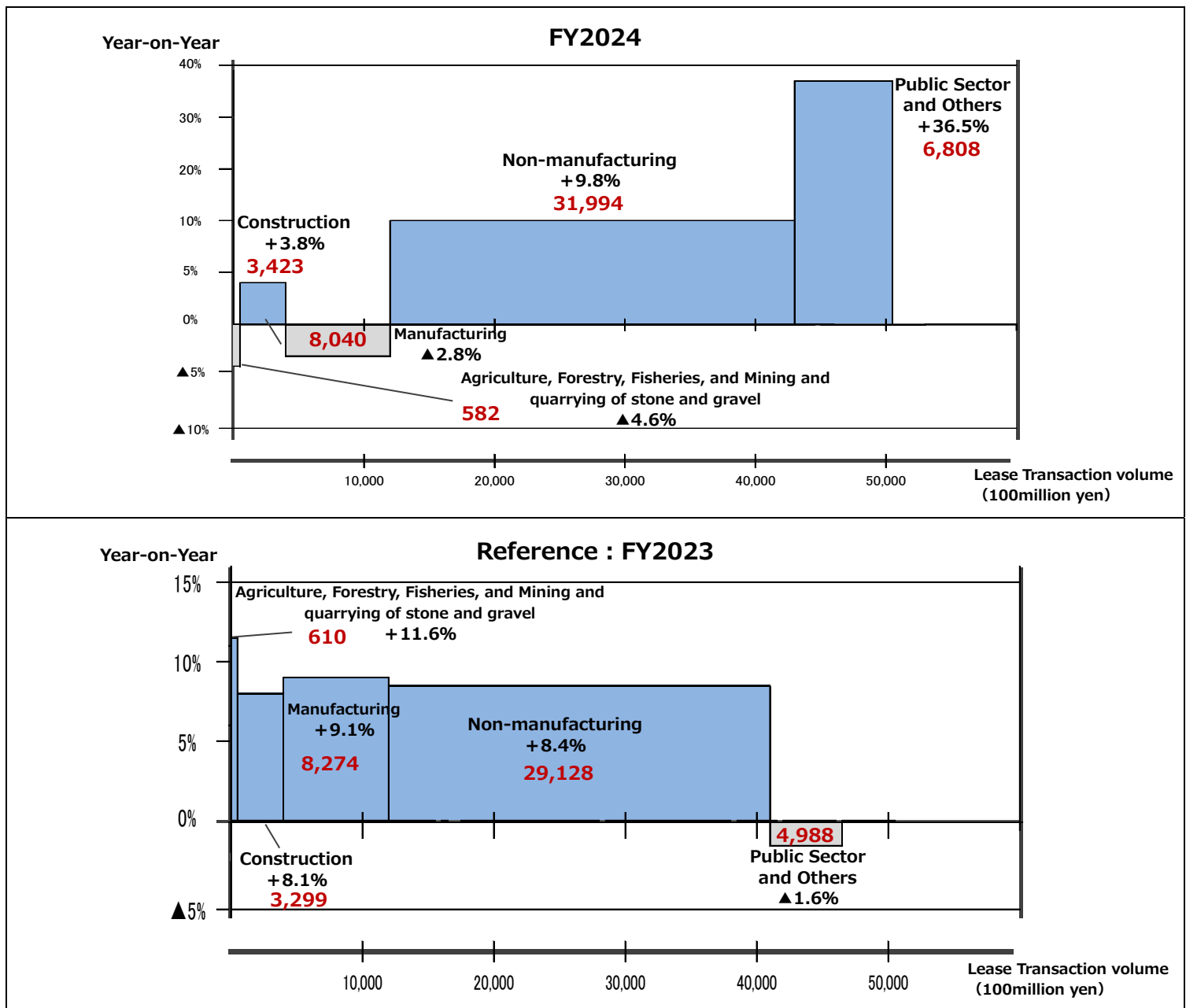
Trends in Lease Transaction Volume by Size of Lessee and Lessee's Business Type

<Trends in Lease Transaction Volume by Size of Lessee>

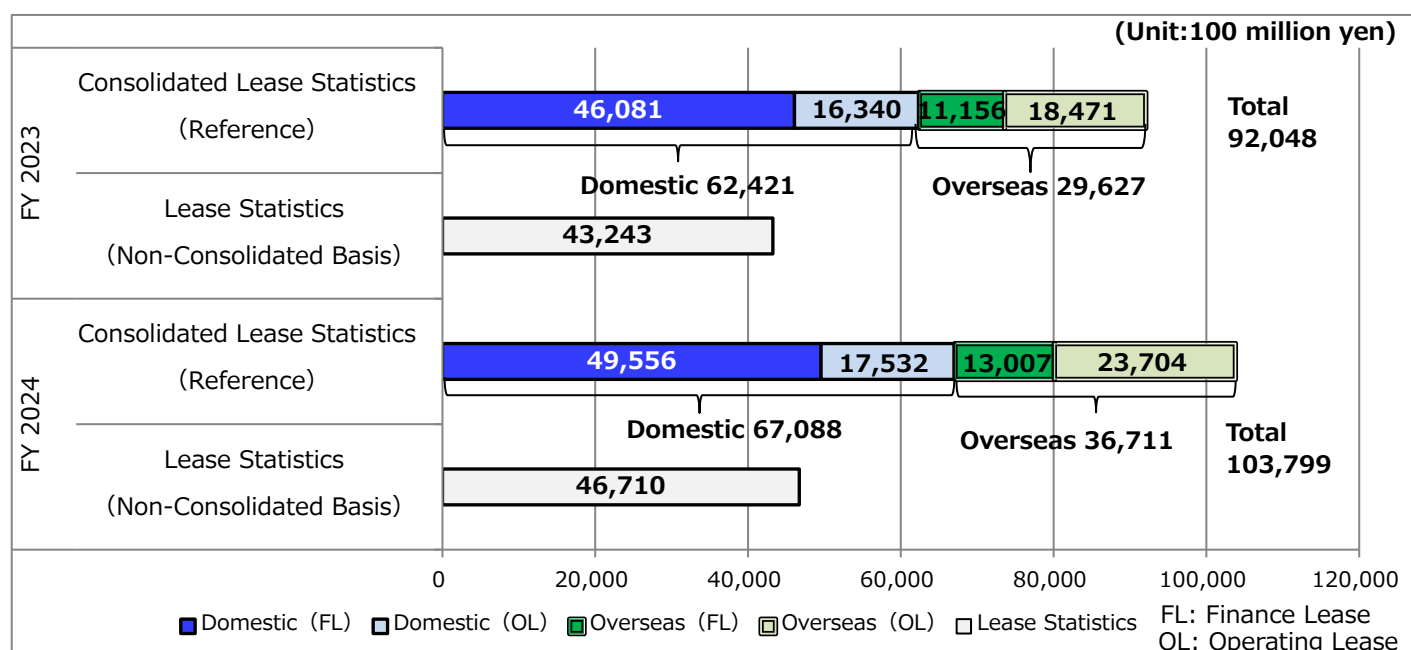


<Trends in Lease Transaction Volume by Lessee's Business Type>

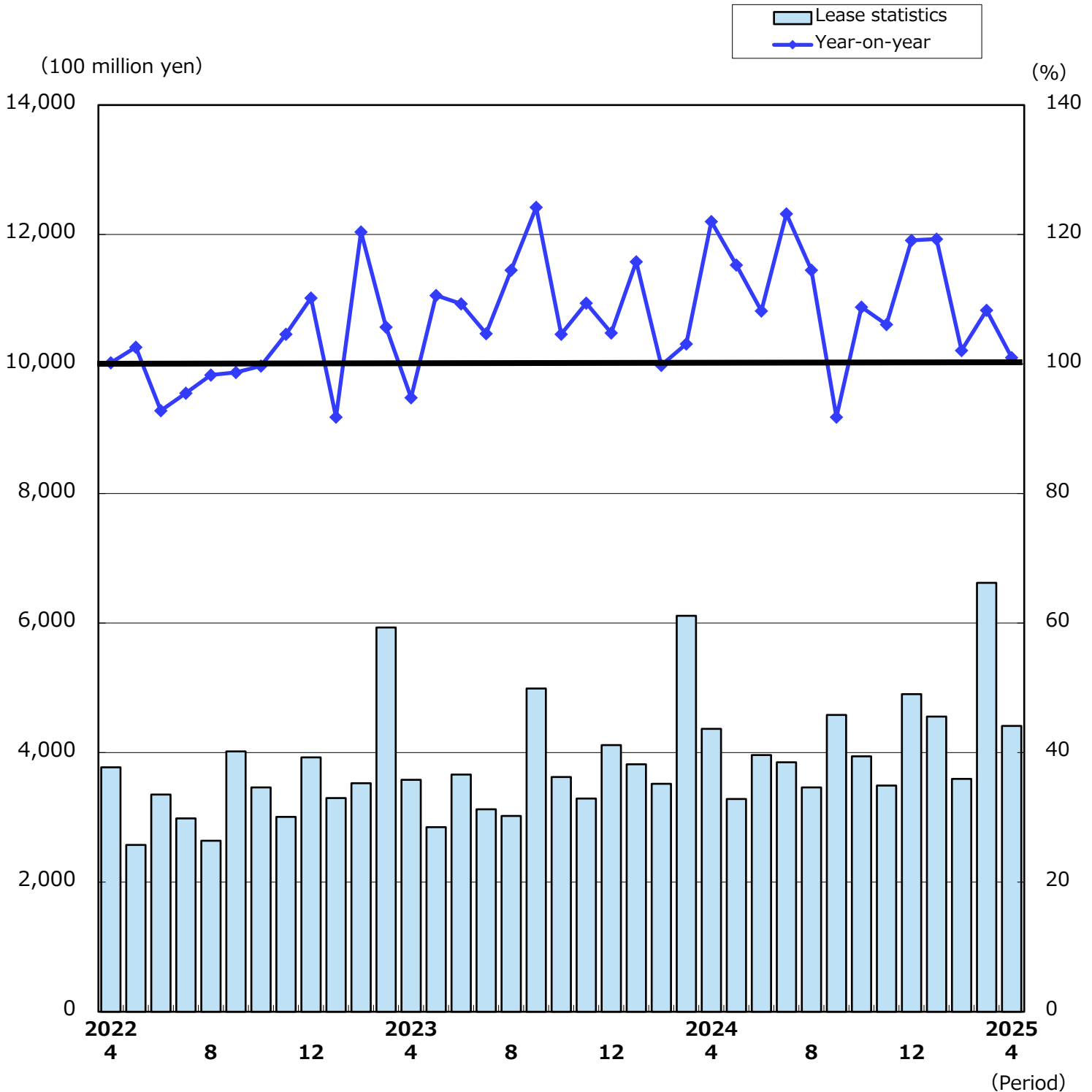

(Overview)

- The lease transaction volume in April 2025 is 441.2 billion yen, increased by 1.0%, and increased in a row of 7 months.
- Information and Communication Equipment (3.5% up), Office Equipment (4.1% up), Factory Equipment (1.5% up), Medical Equipment (11.5% up), Commercial and Service Equipment (3.0% up) increased.
- Industrial Equipment (3.6% down), Construction Equipment (13.9% down), Transport Equipment (1.7% down) decreased.
